### **Executive Director – NIP Group E. Miller**

- o **Financial Fast Track** Mr. Miller advised that there were 176 claims in a 3 month period. The Fast Track continues to show a modest surplus. As the PEJIF grows so will the Fast Track report's utility as a snapshot of the Fund's financial position.
- o **Committee Formation -** Since the PEJIF is has only four members, it is advisable to forego formation of the working committees at this time. With additional members, we can start forming the Fire Fighters and Police Safety Committees and DPW Roundtable.
- o **East Orange and Roselle Status** Roselle is still scheduled to join the PEJIF on 7/1/14. East Orange has not made a final decision but also looks like they might be onboard on 7/1/14.

# <u>SAFETY DIRECTOR - Anthony Ven Graitis, Vice President Risk Control & Wendy Wiebalk, Litigation Manager)</u>

- o **In2vate Initiate Training update A. Ven Graitis** In2vate training is now available to at least one administrator at each municipality. To make it even easier to schedule training, Debbie or Anthony can create classes/register students to eliminate any issues with using the system. The goal is to provide at least 25% of all training via on-line classes. The system allows training to be tracked, progress of individual classes to be reviewed, and reports to be generated for employees or groups.
- o **SERVE Training update A. Ven Graitis** SERVE training is currently being reviewed by Passaic and Perth Amboy. The on-line training is available for emergency responders and specific modules are available for Police, Fire and EMS.
- o Loss Trending A. Ven Graitis NIP is now reviewing and evaluating loss data per municipality, normalizing the data to the exposure to better identify areas that require specific loss control efforts. Risk Control personnel may initiate loss control initiatives for individual members based on findings. Loss information will also be prepared and reviewed at SCM's to ensure proper loss control responses to mitigate or eliminate hazards.
- New Jersey Pregnant Worker's Fairness Act W. Wiebalk Wendy spoke about the NJPWFA, the amendment to NJLAD to include same, and the potential ramifications for employers



Claims Manual Highlights - Robert Persico - Bob advised the PEJIF Claims Manual was distributed to the TPA's on April 9, 2014. The manual provides the TPA's with coverage information, reporting requirements, case management expectations, financial management, case law and exhibits.

Treasurer's Report – Patrick DeBlasio - Mr. DeBlasio reviewed the monthly treasurer's report
and cash management account and advised that the Fund has met all outstanding obligations and
its financial position is secure.
