- Fast Track Report We have only received fast track reports for month of July and August which
 was included in the October packet. We should have the September report later this week which will
 be sent to attendees as soon as it is completed.
- o **Renewal Update** Mr. Hall indicated that excess renewals quotes are starting to come in. We have already received 6 out of the 7 member renewals. We will have the 2016 draft budget ready and will share this information at our next PEJIF meeting on 11/10.

SAFETY DIRECTOR (Anthony Ven Graitis and Debbie Perillo)

- O Police Training: Brit Seminar Recap, Connell Consulting, TACT -Brit Insurance hosted their inaugural regional risk management seminar titled, "Liability Prevention and Risk Management in Law Enforcement: Tips for Improvement in Ten Areas that Make a Real Difference," on Thursday, October 15, 2015, 9:00 a.m. to 2:00 p.m. at the Senior Citizens Center in Union. Approximately 70 people attended. The speakers were Randy Means, founding partner of the Charlotte-based Thomas & Means Law Firm, specializes entirely in police operations and administration and assists a broad national clientele, and Sgt. Jim Craige of the Alexandria (VA) Police Department where he manages its Tactical Computer System. Topics included Recruiting and Hiring the Right People to be Police Officers, Proper Use of Policy and Directives Manuals, Enhanced but Low-Cost Training and Testing Systems, Managing Use of Force and High Speed Driving, and Use of Body Worn Cameras and Other Recording Devices.
- o **Safety Incentive Program update** Safety incentives will be awarded at the end of 2015. As a reminder, on line training is a component of the award and 50 seats must be taken in SERVE or TEAM/In2vate for members to be eligible for awards.  all applicable member departments, and posted in the appropriate public locations.
- o **Personal Protective Equipment -** A reminder that PPE must be provided to all employees. Regardless of budget demands, safety must remain every member's top priority and it starts with properly protecting employees with the appropriate PPE.





Treasury Yields and World Bond Yields








