# **Emergency Medical Services**

#### **Automated External Defibrillator (AED)**

DURATION: 30 MIN

MEDICAL SERVICES

#### COURSE OVERVIEW

In some first aid situations, the victim's heart will be beating too quickly or in an irregular manner. In cases like these, an automated external defibrillator, also known as an AED, can be used to shock the person's heart back into a normal rhythm. In this course, you'll learn when and how to use an AED, including an automatic AED and a semi-automatic AED.

#### **Bleeding Emergencies**

DURATION: 30 MIN COURSE OVERVIEW

There are certain cases when a person is bleeding that are always emergencies. These include extreme blood loss, amputations, abdominal evisceration wounds, sucking chest wounds, and internal bleeding. This course explains the importance of calling for emergency medical assistance in these situations and lists the appropriate steps of first aid to provide.

#### Burns

DURATION: 30 MIN COURSE OVERVIEW

Burns are a common occurrence in life, including at work. These may be something as simple as a sunburn or as frightening as a radiation burn. Burns are generally discussed in terms of their severity first degree, second degree, and third degree. In this course, you'll learn how to prevent burns from occurring at work, how to recognize the degree of a burn, how to provide first aid for different degrees of burns, and how to provide first aid for special types of burns, including electrical burns, burns from chemical spills, and thermal (heat) burns.

#### **First Aid**

When emergency situations arise, having an understanding of how to respond with the appropriate First Aid is the most useful tool available. # Fire

#### **First Responder Operations Level Refresher** DURATION: 8 HR

#### COURSE OVERVIEW

This course is designed to be a refresher for the **Operations Level Responder to Hazardous Materials** Incidents, meeting the requirements of NFPA 472 and 29 CFR 1910.120(q). It is divided into four modules (approximately two hours each). Module 1 covers how to survey a hazmat spill or incident. Module 2 covers chemical and physical properties of materials, their impact on storage and transport containers; response objectives, including assessing risk for each hazard class; and determining the suitability of SCBA and personal protective equipment. Module 3 covers the principles of site management, establishing and enforcing control zones, and tactics for emergency decontamination. Module 4 covers incident management systems and first responder roles in a response plan (including potential terrorist attacks, agents used in a terrorist events, and appropriate response tactics).

### Aggressive Patient DURATION: 1 HR 30 MIN

#### COURSE OVERVIEW

This course will assist EMS professionals to recognize and manage threats from the occasional aggressive patient. It provides Law Enforcement and EMS providers three major deliverables. OSHA Guidelines: For the protection of healthcare workers since everyone working in this field must understand the steps to workplace compliance. Tools to Understand the Six "Ladder Steps": Comprised of escalating behavioral changes (including identifying non-verbal clues among individuals in custody or protective care). The Logical "Do's & Don'ts"; to minimize risk in managing the aggressive patient.

### Fire Service Leadership Collaboration

#### DURATION: 1 HR 30 MIN COURSE OVERVIEW

The fire service today represents a common name for increasingly diverse organizations. Sixty or Seventy years ago fire departments were pretty much the same in functional organization. However, today's fire duty has been reduced on a national basis. Don't take this information negatively. Part of the fire services' collective mission is to prevent fire. However, the potential for fire loss, loss of life and loss of property, remains. We still need firefighters to respond to extinguish fires. The question becomes "How do we maintain sufficient firefighter staffing while fires continue to decline?" In this course, we discuss how many fire departments today have embraced a number of additional missions to augment the reduction in fire duty.

#### E.V.O.D. - Emergency Vehicle Operations Driving DURATION: 4 HR 30 MIN

#### **COURSE OVERVIEW**

Your department's investment in automobiles, firefighters, and insurance are a large expense of your annual operations. This course will provide great training to help minimize the risk to officers and the expense to your agency and your tax paying citizens. This course teaches firefighters to clearly understand and consistently operate their vehicles with the utmost care and the highest operational professionalism. 3D graphics help firefighters envision potential scenarios so they can respond appropriately when such circumstances arise. Consistent and constant training on Emergency Vehicle Operations Driving (EVOD) is an essential skill that could save lives.



# Police

#### Applied Ethics/Becoming an Exemplary Peace Officer DURATION: 30 MIN

#### **COURSE OVERVIEW**

The absolutely highly ethical services performed as a peace officer are critical to the well being of the community. Officers must be qualified in terms of integrity, ethics, character and commitment to perform a wide range of vital tasks. This course strengthens character and helps students develop the knowledge, abilities, and skills that will allow them to be exemplary peace officers. In addition to workplace diversity, police officers will need to understand and respect the cultures of members of the public whom they encounter. This hands-on, interactive, scenario-based training is essential as society continues to diversify.

#### Use of Force DURATION: 2 HR COURSE OVERVIEW

Assuring the Legal Validity of the Core Transaction details three types of citizen contacts: Voluntary Contact, Investigative Detention, and Arrest. Maintain Proportionality and Manage Force Escalation(s) discusses standards and policies, and instructs officers on essential characteristics and the 14 Personal Force Factors, or Situational Dynamics. Avoiding Peripheral Poisonings emphasizes how officer behavior may influence others' perception of the situation, and illustration is provided through a reenacted case study.
