EXECUTIVE DIRECTOR'S REPORT (Jonathan Hall)

- **Mid-Year Actuarial Analysis -** The Administrator's office has finalized Mid-Year Actuarial Report. Mr. Hall shared highlights of the analysis. There were no questions.
- **Fast Track Report** We have updated the Fast Track Reports for June, July and August 2020 and will be distributing the reports to all members this week.
- Treasurer's Report All Bills have been paid and our cash balance is secure.
- 2021 Actuarial Rate Study and Draft Budget Status The Fund Actuary is working on the Rate Study for the 2021 Budget and is estimated to complete their work next week. We plan to distribute the 2021 draft budget prior to the next Fund Meeting.
- **Indemnity & Trust Agreements for 2021 -** The Administrator's office requests that renewing members please return the Resolutions to Rejoin as soon as they are passed by your governing bodies and executed accordingly.
- Requests for Proposals / Qualifications Update The due date for the 2021 Requests for Proposals/Qualifications was October 13th, 2020. A summary of all proposals received will be distributed for the November 24th Fund Meeting.
- 2021 Excess Renewal Update Our excess partners are in receipt of our complete underwriting submission. They have issued the first round of indications and we are currently in negotiations. As always, our goal continues to be achieving the most thorough and cost-effective program for our members.
- **2021 Prospects -** The Underwriting Department has received 2 submissions for the 2021 program year.
- **2021 Member Applications** Members are reminded to submit completed, signed applications for the 2021 renewal. Certain lines cannot be bound without applications.
- **Member Portal** The PEJIF member portal remains the easiest way to update all exposures, complete and generate applications.
- **Snow-Plow Rodeo** The 2020 Snow Plow Rodeo will be held on November 5, November 9, and November 16. Social distancing guidelines will be enforced.
- National Cyber Security Awareness Month October is Cyber Security Awareness Month. Members are asked to assign Cyber Awareness Training to all employees via the PEJIF Vault.
- **Driver Training & Deer Season** Members are encouraged to assign Defensive Driving-Reducing Deer-Related Accidents training to all municipal drivers via the PEJIF Vault.
